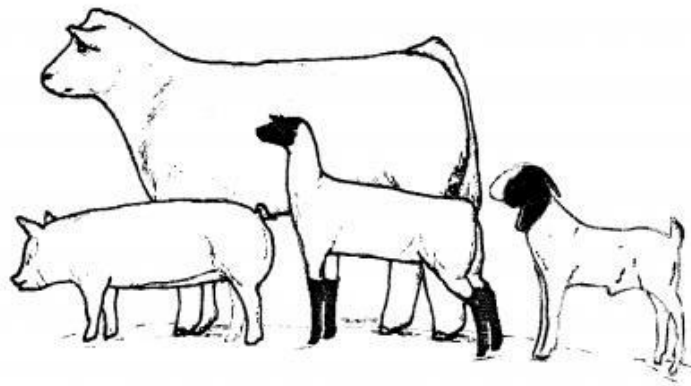

Commercial Exhibitors must clean their stalls/pens or forfeit your premiums.

Be prepared to show all health papers to the State Inspector when asked. Every exhibitor must have a premise ID number.

Notes: 4-H Feeder Calves cannot be entered in the open class. All bovine animals should have a safety rope plus halter.

Code of Ethics: To exhibit market animals in an ethical manner and therefore the Barbour County Livestock Association has adopted the International Association of Fairs & Expositions (IAFE) National Code of Show Ring Ethics and its accompanying “Exhibitor Entry Statement” which is included on the livestock entry form and which livestock exhibitors are required to sign.

IAFE (International Association of Fairs & Expositions) National Code of Show Ring Ethics: Exhibitors of animals at livestock shows shall at all times deport themselves with honesty and good sportsmanship. Their conduct in this competitive environment shall always reflect the highest standards of honor and dignity to promote the advancement of agricultural education. This code applies to junior as well as open class exhibitors who compete in structured classes of competition. This code applies to all livestock offered in any event at a livestock show. In addition to the “IAFE National Code of Show Ring Ethics,” fairs and livestock shows may have rules and regulations which they impose on the local, county, state, provincial and national levels.

All youth leaders working junior exhibitors are under an affirmative responsibility to do more than avoid improper conduct or questionable acts. Their moral values must be so certain and positive that those younger and more pliable will be influenced by their fine example. Owners, exhibitors, fitters, trainers and absolutely responsible persons who violate the code of ethics demean the integrity of all livestock exhibitors and should be prohibited from competition at all livestock shows in the United States and Canada.



Lamb Tail Policy:

Lambs should be docked according to the American Veterinary Medicine Association official policy. This policy reads as follows: ***Lambs' tails are docked for cleanliness and to minimize fly strike, but cosmetic excessively short tail docking can lead to an increased incidence of rectal prolapses and is unacceptable for the welfare of the lamb. We recommend the lambs' tail be docked at the level of the distal end of the caudal tail fold.***

Beginning January 1, 2017 market lambs or breeding sheep entered in 4-H/FFA sponsored youth fair exhibits will be observed by Extension and/or FFA personnel for evidence of rectal prolapse. Any lamb exhibiting any signs of rectal prolapse will be disqualified from the event, any official tags removed, and the animal removed from the premises.

All 4-H & FFA Youth livestock & Commercial livestock will be inspected by the WV Dept. of Agriculture before they can be unloaded from trailers.

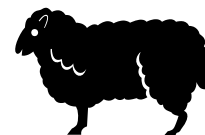

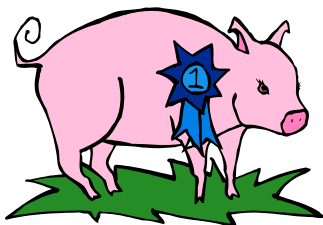

- E. Goats must carry all kid teeth and will be mouthed at time of official tagging. Wether goats with evidence of testicular tissue will not be allowed to show.
- F. All goats must be dehorned or properly tipped and properly healed to show or be fitted with approved horn guards. No sharp points allowed.
- G. Meat goats must be part of exhibitor's 4-H or FFA project and exhibitor must complete record guide and project books to receive premium award.
- H. Exhibitor must own meat goat by first week in June.
- I. All meat goats must meet the current WV Dept. of Agriculture Health Requirements.
- J. Goats with signs of foot rot, sore mouth, open sores, or other illness will not be allowed to exhibit.

Rules & Regulations (Open Meat Goat Show)

This show is for meat type goats only

Only Barbour County residents are eligible to show. Exhibitors who may be pre 4-H age must be able to actively show the entered animals but may have an older person help as a header/heeler in the show ring.

All animals must meet all WV Dept of Agriculture health requirements.

Animals shown in the Boer and Kiko classes must have registration papers. All others will be entered in the commercial classes using recorded birthdates.

Only females will be shown. Only animals that are entered in their respective classes will be allowed on the fairgrounds; with the exception that the does of the kids in the 0-3 month classes may be allowed to be on the fairgrounds for their kids.

Goats shown in this department can only be shown in this department's classes and are NOT eligible for the 4-H/FFA Market Animal Sale.

Barbour County Fair Rules & Regulations Pertinent to Livestock Exhibitors

1. Fair Association reserves, to its board of directors, the right to interpret all rules and regulations and to arbitrarily settle all matters in regard to them (a)all protests must be in writing, must state plainly the complaint, be accompanied by a fee of \$10 which shall be forfeited to the Fair Association in case protest is not sustained, and must be delivered to the Board of Directors within 12 hours after cause of protest.
2. In any class where there is no competition, a ribbon will be awarded (if worthy) and second money paid. Unless otherwise stated on Department Rules, two or more entries in a class by one exhibitor will be considered competition. Additional classes may be added for those items not listed. However, ribbons will be awarded and no premium money will be paid for those added classes. Added items will be considered for the next year's fair exhibits.
3. Removal of ribbons before exhibits are removed will forfeit right to premium money.
4. In case all exhibits in any class are inferior quality, the judges reserve the right to place exhibits according to their best judgment.
5. The board of directors will have complete authority over all exhibits, but in no case will be responsible for any loss or damage that may occur.
6. All exhibits must be registered at the department where that particular exhibit is displayed by the owner.
7. Livestock exhibitors must provide their own labor in watering and caring for their animals and keeping stalls clean.
8. The Fair Association will use every means in their power for the protection of the personnel and property of those persons entering upon the grounds either as exhibitors or spectators; however, in no case will they assume responsibility for the safety of either persons or property.

9. Admission at the gates will be \$12 per person Tuesday – Saturday. Absolutely no refunds. There will be no charge on Sunday and Monday.
10. Exhibits left on the fairgrounds after Sunday evening, September 1st will become the property of the Fair Assoc. and will be disposed of in any manner it sees fit.
11. The Fair Association will not tolerate dangerous animals on the grounds or mistreatment to the animals.
12. Soliciting on the fairgrounds is prohibited by the Fair Association except by special official action of the Board of Directors.
13. The fair association will provide security.
14. The Fair Association reserves the right to pro-rate premium money in case of insufficient funds. All checks for premiums must be cashed 30 days after date.
15. Commercial exhibitors will not remove exhibits before 10 pm on Saturday, Aug. 31st.
16. All youth livestock & commercial must be in exhibit space at 6 pm, Wed., Aug 28.
17. Commercial Livestock may be removed at 1 pm, Saturday, August 31st or when released by the livestock exhibit chairman.
18. No motor bike or ATV riding on midway or fairgrounds, except by fair officials.
19. Animal exhibitors must keep area clean around animals or forfeit right to show.
20. All workers in the exhibit barn are volunteers.
21. Any exhibit which is not listed in the book can be displayed at the fair, however, no premium will be paid.
22. Commercial livestock exhibitors - \$5.00/\$3.00 entry fee cattle/small animals per head. Bedding must be provided by exhibitor.
23. Any 4-H/FFA market animal not eligible for the 4-H/FFA market animal auction must be removed from the fairgrounds by noon on Saturday, August 31st.
24. The Barbour County Livestock Association reserves the right to limit livestock numbers.
25. The health regulations promulgated under the authority of Chapter 19, Article 7 of the Code of West Virginia apply to the Barbour County Fair. A copy of the interpretation of the rules as they apply can be secured by writing to: Barbour County Fair, P O Box 87, Philippi WV 26416 or by calling (304)823-1328. The Barbour County Fair Livestock Sale for the 4-H and FFA animals is set for 7:30 pm on Saturday, Sept. 1st. The sale is sponsored by the Barbour County Livestock Association. General rules and regulations are in effect in cooperation with the Barbour County Fair Association, WV Dept. of Agriculture, WVU Extension Service, Jody Carpenter, Commission and Barbour County Parks & Recreation.
